## EXECUTIVE ORDER NO. 06 Series of 2021

AN ORDER EXTENDING THE MODIFIED GENERAL COMMUNITY QUARANTINE IN THE PROVINCE OF DAVAO ORIENTAL UNLESS LIFTED, MODIFIED OR WITHDRAWN AND ADOPTING THE OMNIBUS GUIDELINES OF THE INTER-AGENCY TASK FORCE EMERGING INFECTIOUS DISEASES AND FOR OTHER PURPOSES

**WHEREAS**, President Rodrigo Roa Duterte issued Executive Order No. 112 imposing an enhanced community quarantine in high-risk areas and a general community quarantine in other parts of the country and adopting the *Omnibus Guidelines* in the implementation thereof;

WHEREAS, the National Inter-Agency Task Force for the Management of Emerging and Reemerging Infectious Diseases has issued the Omnibus Guidelines on the implementation of Community Quarantine in the Philippines with amendments as of June 25, 2020;

**WHEREAS**, the province of Davao Oriental will remain under Modified General Community Quarantine but under medium risk pursuant to the pronouncement from National Inter-Agency Task Force for the Management of Emerging and Re-emerging Infectious Diseases;

**WHEREAS**, the Inter Agency Task Force on Emerging Infectious Diseases (IATF-EID) released Resolution no. 101 on February 27, 2021 relative to the new protocols on testing, quarantine and other travel protocols;

WHEREAS, the Local Government Units are expected to act as stewards of local health systems, primary responders to the public health emergency, and to implement calibrated and people-centered response including primary to tertiary care in an integrated and coordinated manner;

**NOW, THEREFORE**, by the authority vested in me as Provincial Governor by the Constitution and the laws of the Republic of the Philippines, I, **NELSON L. DAYANGHIRANG**, do hereby order:

### SECTION 1. DECLARATION.

The implementation of the Modified General Community Quarantine in the Province of Davao Oriental is hereby extended pursuant to the declaration of the Inter Agency Task Force on Emerging Infectious Diseases on the quarantine classification unless otherwise modified or withdrawn. The omnibus guidelines for modified general community quarantine shall hereby be followed in the conduct of activities and other events in the province.

### **SECTION 2. ADOPTION**

Resolution No. 101 by the IATF EID is hereto adopted to ascertain uniformity in all quarantine and travel protocols. However, the following safeguards are hereto imposed to wit:

- 1. Returning Overseas Filipinos (ROFs) and local travellers planning to stay longer than five days in the Province of Davao Oriental shall be advised to stay at home for five days with surveillance screening;
- All asymptomatic ROFs and local travellers will be put on active surveillance. In any eventualities that symptoms will occur within the fourteen-day period, they shall be immediately isolated at the barangay isolation unit or any designated local isolation facility whichever is available

### SECTION 3. INTENSIFIED USE OF THE DAVAO ORIENTAL DIGITAL CONTACT TRACING SYSTEM

Given the new travel protocols set forth by the IATF-EID, all establishments shall strictly adhere to the use of the DAVOR-DCTS (use of quick response code) to aid in all contact tracing measures of the province and city/municipality. Use of manual logbook and/or manual listing, especially at entry/exit points in borders and establishments, are strongly discouraged to curb transmission.

### **SECTION 4. SEPARABILITY CLAUSE.**

If, for any reason, any part or provision of this Order shall be found unconstitutional or invalid, other parts or provisions thereof which are not affected thereby, shall continue to be in full force and effect.

#### Section 5. REPEALING CLAUSE.

Previous issuances or parts thereof in conflict with or inconsistent to the provisions of this Executive Order are hereby repealed or modified accordingly.

### Section 6. EFFECTIVITY CLAUSE.

This Executive Order shall take effect immediately.
