EXECUTIVE ORDER NO. 12 Series of 2021

AN ORDER ADOPTING THE JOINT REGIONAL INTER-AGENCY TASK FORCE FOR THE MANAGEMENT OF EMERGING INFECTIOUS DISEASES – REGIONAL TASK FORCE AGAINST COVID-19 (RIATF - RTF) XI RESOLUTION NO. 01, SERIES OF 2021 AND FOR OTHER PURPOSES

WHEREAS, President Rodrigo Duterte issued Presidential Proclamation 1021 extending the State of Calamity in the country until September 12, 2021 due to the COVID-19 pandemic;

WHEREAS, there is a surge and emergence of new COVID-19 variants of cases in the National Capital Region (NCR) and other areas in the country and one of the recommendations of the Department of Health – Center for Health Development (DOH-CHD) XI as ways forward for Local Government Units (LGUs) is the strict screening of travelers between borders;

WHEREAS, the COVID 19 Regional Inter Agency Task Force in Region 11 (RIATF-RTF XI), through Resolution No. 01, Series of 2021, provided region-wide border control guidelines to regulate movement into and from Region XI;

WHEREAS, such guide is necessary to curb COVID-19 cases transmission and as a preemptive measure against surge of cases in the region;

NOW, THEREFORE, I, NELSON L. DAYANGHIRANG, Governor of the Province of Davao Oriental, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. ADOPTION.

The RIATF – RTF XI Resolution No. 01, Series of 2021 entitled "UNIFORM GUIDELINES TO REGULATE ENTRY AND EXIT IN REGIONAL BORDERS OF REGION XI" which is attached herewith is hereby adopted in toto.

SECTION 2. COVERAGE.

The RIATF – RTF XI Resolution No. 01, Series of 2021 shall only be applicable in all Province of Davao Oriental checkpoints on the border with other regions (eg. Boston-Surigao Border).

SECTION 3. STRICT OBSERVANCE OF MINIMUM HEALTH PROTOCOLS

Everyone is enjoined for the continued observance of standard minimum health protocols to ensure the safety of everyone.

Section 4. SEPARABILITY CLAUSE.

If, for any reason, any part or provision of this Order shall be found unconstitutional or invalid, other parts or provisions thereof which are not affected thereby, shall continue to be in full force and effect.

Previous issuances or parts thereof in conflict with or inconsistent to the provisions of this Executive Order are hereby repealed or modified accordingly.

Section 6. EFFECTIVITY CLAUSE.

This Order shall take effect on 12:01AM of May 15, 2021.
