



EXECUTIVE ORDER NO. 27-As.2021

RECONSTITUTING THE COMPOSITION OF THE PROVINCIAL LOCAL SCHOOL BOARD

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandated the creation of the Local School Board in every provincial, city or municipality;

WHEREAS, the provincial school board shall be composed of the governor and the division superintendent of schools as co-chairmen; the chairman of the education committee of the sangguniang panlalawigan, the provincial treasurer, the representative of the pederasyon ng mga sangguniang kabataan in the sangguniang panlalawigan, the duly elected president of the provincial federation of parents-teachers association, the duly elected representative of the teachers' organization, and the duly elected representative of the non-academic personnel of public schools in the province, and the civil society organizations, as members;

WHEREAS, the provincial local school board deems the necessity to expand its membership to other sector in the society, such as tourism, culture and the arts;

NOW, THEREFORE, I, NELSON L DAYANGHIRANG, Provincial Governor of Davao Oriental by virtue of the powers vested in me by law and pursuant to Article 184 of the Rules and Regulations Implementing RA 7160, do hereby order the reconstitution of the composition of the Provincial Local School Board:
