**AN ORDINANCE AMENDING PROVINCIAL ORDINANCE NO. 16-75-10-2021, ENTITLED: "APPROVING FOR THE CREATION AND FUNDING OF VARIOUS POSITIONS OF DIFFERENT OFFICES OF THE PROVINCE OF DAVAO ORIENTAL, CHARGEABLE AGAINST THE CALENDAR YEAR 2022 GENERAL FUND ANNUAL BUDGET OF THIS PROVINCE.", AS AMENDED BY PROVINCIAL ORDINANCE NO. 16-77-11-2021, BY CHANGING SOME PROVISIONS THEREOF, CONSISTENT WITH THE APPROVED CY 2022 PERSONNEL SCHEDULE OF THE PROVINCE.**

**WHEREAS**, Provincial Ordinance No. 16-75-10-2021 was enacted by the Sangguniang Panlalawigan on October 13, 2021 Regular Session, approving the creation and funding of various positions of different offices of this province;

**WHEREAS**, Provincial Ordinance No. 16-77-17-2021 was enacted by the Sangguniang Panlalawigan on November 3, 2021 Regular Session, amending the

**SECTION 2. IMPLEMENTATION** – The implementation and execution of this Ordinance shall be subject to the existing and applicable Civil Service Laws, Rules and Regulations, and shall be in accordance with relevant budget circulars of the Department of Budget and Management and other pertinent laws thereof.

**SECTION 3. REPEALING CLAUSE** – All existing measures with a provision or provisions which are inconsistent with this ordinance, the same are hereby amended or repealed accordingly.

**SECTION 4. SEPARABILITY CLAUSE** - Should any provision of this Ordinance is found invalid and declared unconstitutional, the rest of the provisions not otherwise affected shall remain effective and enforceable.

**SECTION 5. EFFECTIVITY** - This Ordinance shall take effect upon its approval.
