PROVINCIAL ORDINANCE NO. 16-82-01-2021

AN ORDINANCE CREATING THE POSITION OF ONE (1) ADMINISTRATIVE ASSISTANT IV (BOOKBINDER IV) (SG-10) UNDER THE PROVINCIAL PLANNING AND DEVELOPMENT OFFICE, THIS PROVINCE.

WHEREAS, the Local Chief Executive has requested the Sangguniang Panlalawigan to pass an ordinance creating various positions under the different offices of this province, including One (1) Administrative Assistant IV (Bookbinder IV) (SG-10), under the Provincial Planning and Development Office, funding of which is chargeable against the CY 2022 General Fund of the province;

WHEREAS, the said position, along with the other newly created positions, is vital in the operation of the LGU to meet the needs of the present demand of a very functional and responsive government institution;

WHEREAS, the said position was not included in the Provincial Ordinance No. 16-75-10-2021, an ordinance creating various positions under the different offices, which was enacted on October 13, 2021;

WHEREAS, Section 76 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirement and financial capability, subject to the minimum standard and guidelines prescribed by the Civil Service Commission;

WHEREFORE, on motion of SP Member Nelson R. Dayanghirang, Jr., duly seconded by SP Member Rabsalon M. Lamarin, it was

Be it ordained by the 16th Sangguniang Panlalawigan of Davao Oriental in session duly assembled that:

SECTION 1. CREATION OF POSITION – The creation of One (1) Administrative Assistant IV (Bookbinder IV) with Salary Grade 10 under the Provincial Planning & Development Office is hereby approved.

SECTION 2. FUNDING - Funding of the newly created position is already included in the CY 2022 General Fund of this Province.

SECTION 3. IMPLEMENTATION – The implementation and execution of this Ordinance shall be subject to the existing and applicable Civil Service Laws, Rules and Regulations and shall be in accordance with relevant budget circulars of the Department of Budget and Management and other pertinent laws thereof.

SECTION 4. REPEALING CLAUSE – All existing measures with a provision or provisions which are inconsistent with this ordinance, the same are hereby amended or repealed accordingly.

SECTION 5. SEPARABILITY CLAUSE - Should any provision of this Ordinance is found invalid and declared unconstitutional, the rest of the provisions not otherwise affected shall remain effective and enforceable.

SECTION 6. EFFECTIVITY - This Ordinance shall take effect upon its approval.


