A RESOLUTION ADOPTING THE MODIFIED POSITION ATTRIBUTES OF NURSE POSITIONS EFFECTIVE JUNE 1, 2021, PURSUANT TO DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) BUDGET CIRCULAR NO. 2021-2 DATED AUGUST 25, 2021.

WHEREAS, DBM Budget Circular 2021-2 is issued to prescribe the rules and regulations on the upgrading of the previous Nurse II positions from SG-15 to SG-16, as well as to provide the administrative processes for the retention of the position titles of Nurse III to Nurse VII with their corresponding SG assignments;

WHEREAS, the Salary Grade allocation of the former Nurse II (SG-15) position is hereby upgraded by one (1) SG effective not earlier than June 1, 2021, from SG 15 to SG 16, adjustment on the new salary rates shall be in accordance with the applicable Salary Schedule adopted by the LGU pursuant to the provisions of Item 6.5 of Local Budget Circular No. 132 dated January 19, 2021;


