AN ORDINANCE **APPROVING** THE **FUNDING** OF PROGRAMS/PROJECTS/ ACTIVITIES OF THE PROVINCE IN THE TOTAL AMOUNT OF P38,570,262.00, CHARGEABLE AGAINST THE UNRELEASED LOAN BALANCE FROM THE EXISTING P650 MILLION DBP LOAN.



WHEREAS, the Province of Davao Oriental entered into a Contract of Loan with the Development Bank of the Philippines (DBP) in the amount of Six Hundred Fifty Million (P650,000,000.00) Pesos for the Improvement of Tourism Complex, Construction/Rehabilitation of Hospitals/Multi-purpose Buildings/Centers, Potable Water System, and Procurement of Brand New Light and Heavy Equipment for Motor Pool;

WHEREAS, from the amount released, the amount of P611,429,738.00 was utilized for the aforementioned purposes, thus, there is an unreleased loan balance of P38,570,262.00. and is available for utilization to fund various programs/projects/activities (PPAs);

WHEREAS, due to the growing demand for infrastructure and utility services, the Provincial Government needs to procure additional heavy/light equipment, thus, there is also a need to improve the Motor Pool Building to accommodate the new equipment;

WHEREAS, with the ongoing construction of the Capitol Multi-purpose Building, there is a need to employ architectural/interior aesthetics and provision of furniture for the building;

WHEREAS, the said PPAs support two provincial agenda which are: to improve access to infrastructure, utilities, and social services; and to strengthen effective and efficient governance;

WHEREFORE, on motion of SP Member Anacleto P. Macatabog, unanimously seconded by all the members present, it was

Be it ordained by the 16th Sangguniang Panlalawigan of Davao Oriental, by virtue of the powers vested in it by law, in session assembled, that:

SECTION 1. UNRELEASED LOAN BALANCE - There is an unreleased loan balance of P38,570,262.00 from the existing 650M DBP Loan which covers the following:
