A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 05-2021, OF THE MUNICIPALITY OF LUPON, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 05-2021, of the Municipality of Lupon, Davao Oriental, authorizing its CY 2021 General Fund Supplemental Budget No. 5, involving an appropriation of Four Million Two Hundred Seventy Three Thousand Fifty (P 4,273,050.00) Pesos, was submitted to this Sanggunian for review on October 13, 2021, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

RESOLVED, to declare Appropriation Ordinance No. 05–2021, of the Municipality of Lupon, Davao Oriental, **OPERATIVE IN ITS ENTIRETY**, as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the condition that the re-appropriation of the 20% Development Fund in the amount of P4,273,050.00 shall be in accordance with the approved CY 2020 Annual Investment Program (AIP) / Development Plan pursuant to Sections 287 and 305 (i) of RA 7160; DILG Memorandum Circular No. 2004-130, dated October 1, 2004; DILG-NEDA-DBM-DOF JMC No. 1, dated November 18, 2016; and DILG-DBM JMC No. 2017-1, dated February 22, 2017. Development projects should contribute to the attainment of desirable socio-economic development and environmental outcomes and should partake in the nature of investment or capital expenditures.

RESOLVED FURTHER, to inform the Municipality of Lupon, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Lupon, Davao Oriental, through the Municipal Mayor.




