A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 86, SERIES OF 2021, OF THE MUNICIPALITY OF BOSTON, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY.

WHEREAS, Appropriation Ordinance No. 86, series of 2021, of the Municipality of Boston, Davao Oriental, authorizing its CY 2021 General Fund Supplemental Budget No. 4, involving an appropriation of One Hundred Nine Million Eight Hundred Forty Five Thousand One Hundred Sixty Six Pesos & 36/100 (P 109,845,166.36), was submitted to this Sanggunian for review on November 18, 2021, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

WHEREFORE, on motion of SP Member Anacleto P. Macatabog, duly seconded by SP Member Enrico M. Antopuesto, it was

RESOLVED, to declare Appropriation Ordinance No. 86, series of 2021, of the Municipality of Boston, Davao Oriental, **OPERATIVE IN ITS ENTIRETY**, as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160.

RESOLVED FURTHER, to inform the Municipality of Boston, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

MOREOVER, the Local Government Unit is reminded of the relevant provision under the Budget Operation Manual for Local Government Units issued under Local Budget Circular No. 112, dated June 10, 2016, in relations to Section 56(a) and 327 of RA 7160 and Article 110 of its Implementing Rules and Regulations (IRR) which requires that, "Within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said ordinance to the Department of Budget and Management or Sangguniang Panlalawigan for review."

It is noted further that this ordinance was passed by the Sangguniang Bayan of Boston on October 4, 2021, approved by the Municipal Mayor on October 5, 2021, but was submitted for review only on November 18, 2021. The Municipality is enjoined to observe and comply the above-cited provision.

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Boston, Davao Oriental, through the Municipal Mayor.
