**A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 21, SERIES OF 2021, OF THE MUNICIPALITY OF BAGANGA, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.**

**WHEREAS**, Appropriation Ordinance No. 21, series of 2021, of the Municipality of Baganga, Davao Oriental, authorizing its CY 2021 General Fund Supplemental Budget No. 1, involving an appropriation of **Twenty Four Million Seven Hundred Forty One Thousand Two Hundred Sixteen Pesos & 97/100 (P 24,741,216.97)**, was submitted to this Sanggunian for review on November 23, 2021, pursuant to the provisions of Republic Act No. 7160;

**WHEREAS**, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 21, series of 2021, of the Municipality of Baganga, Davao Oriental, **OPERATIVE IN ITS ENTIRETY**, as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following condition:

- a) The re-appropriation of the 20% Development Fund in the amount of P2,220,716.15 shall be in accordance with the approved CY 2021 Supplemental Annual Investment Program (SAIP) / Development Plan, pursuant to Sections 287 and 305 (i) of RA 7160; DILG Memorandum Circular No. 2004-130, dated October 1, 2004; DILG-NEDA-DBM-DOF JMC No. 1, dated November 18, 2016; and DILG-DBM JMC No. 2017-1, dated February 22, 2017. It is understood that the projects in the Supplemental AIP are likewise deliberated and favorably endorsed by the Municipal Development Council to the Sangguniang Bayan for their approval in resolution form.

**RESOLVED FURTHER**, to inform the Municipality of Baganga, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

**MOREOVER**, the Local Government Unit is reminded of the relevant provision under the Budget Operation Manual for Local Government Units issued under Local Budget Circular No. 112, dated June 10, 2016, in relations to Section 56(a) and 327 of RA 7160 and Article 110 of its Implementing Rules and Regulations (IRR) which requires that, "*Within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said ordinance to the Department of Budget and Management or Sangguniang Panlalawigan for review.*"

**RESOLVED FINALLY**, to send a copy of this Resolution to the Sangguniang Bayan of Baganga, Davao Oriental, through the Municipal Mayor.




