A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 19, SERIES OF 2021, OF THE MUNICIPALITY OF BAGANGA, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 19, series of 2021, of the Municipality of Baganga, Davao Oriental, authorizing its CY 2021 General Fund Supplemental Budget No. 2, involving an appropriation of <a href="Ten Million Eight Hundred Twelve Thousand One Hundred Sixty Nine Pesos & 21/100 (P10,812,169.21)">Ten Million Eight Hundred Twelve Thousand One Hundred Sixty Nine Pesos & 21/100 (P10,812,169.21)</a>, was submitted to this Sanggunian for review on November 23, 2021, pursuant to the provisions of Republic Act No. 7160;

#### THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 19, series of 2021, of the Municipality of Baganga, Davao Oriental, **OPERATIVE IN ITS ENTIRETY**, as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following condition:

a) The re-appropriation for LDRRM Fund in the total of P2,270,379.00 in the General Fund shall be subject to Section 324 (d) of RA 7160 and to the provisions of RA 10121 and its IRR, NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1, dated March 25, 2013 on Allocation and Utilization of the LDRRM Fund and other laws, rules and regulations governing the same. Furthermore, 70% of the 5% of LDRRMF shall be supported with LDRRM Plan, and the same shall be reviewed by appropriate reviewing authority pursuant to LBM No. 78 dated May 15, 2019.

**RESOLVED FURTHER,** to inform the Municipality of Baganga, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

MOREOVER, the Local Government Unit is reminded of the relevant provision under the Budget Operation Manual for Local Government Units issued under Local Budget Circular No. 112, dated June 10, 2016, in relations to Section 56(a) and 327 of RA 7160 and Article 110 of its Implementing Rules and Regulations (IRR) which requires that, "Within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said ordinance to the Department of Budget and Management or Sangguniang Panlalawigan for review."

**RESOLVED FINALLY,** to send a copy of this Resolution to the Sangguniang Bayan of Baganga, Davao Oriental, through the Municipal Mayor.
