

A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 09-2021 OF THE MUNICIPALITY OF LUPON, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 09-2021 of the Municipality of Lupon, Davao Oriental, authorizing its CY 2021 General Fund Supplemental Budget No. 8, involving an appropriation of Ten Million Seven Hundred Thirty Five Thousand One Hundred Twenty Seven Pesos & 07/100 (P 10,735,127.07), was submitted to this Sanggunian for review on December 31, 2021, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

- b) The Service Recognition Incentive (SRI) Bonus shall be in accordance with DBM Budget Circular No. 2021-3, dated November 17, 2021.

RESOLVED FURTHER, to inform the Municipality of Lupon, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Lupon, Davao Oriental, through the Municipal Mayor.
