A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE GOVERNOR NELSON L. DAYANGHIRANG, FOR AND IN BEHALF OF PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE OFFICE OF THE PRESIDENT, REPRESENTED BY THE EXECUTIVE SECRETARY SALVADOR C. MEDIALDEA, RELATIVE TO THE FINANCIAL ASSISTANCE IN THE AMOUNT OF TEN MILLION PESOS (P10,000,000.00) PROVIDED BY THE OFFICE OF THE PRESIDENT, TO THE PEOPLE OF THE SAID PROVINCE, WHO ARE AFFECTED BY THE HEALTH CRISIS BROUGHT ABOUT BY THE CORONAVIRUS DISEASE (COVID-19).

WHEREAS, President Rodrigo Roa Duterte sees the need to provide financial assistance to the Provincial Government of Davao Oriental affected by the health crisis brought about by the Corona Virus Disease (COVID-19);

WHEREAS, the Office of the President (OP) shall release to the Provincial Government of Davao Oriental, the amount of **Ten Million Pesos (P 10,000,000.00)** as assistance charged to Socio-Civic Projects Fund (SCPF);

WHEREAS, that pursuant to the provisions of Chapter 3, Section 465 (vi) of the Local Government Code of 1991, the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to Law or Ordinance.

WHEREFORE, on motion of SP Member Joselito B. Villademoso, duly seconded by SP Member Ronald T. Lara, Jr., it was

RESOLVED, as it is hereby resolved, **GRANTING AUTHORITY TO THE HONORABLE GOVERNOR NELSON L. 


