A RESOLUTION AMENDING SP RESOLUTION NO. 16-1222-2021 BY SPECIFYING THE SITIOS AND BARANGAYS WHERE THE HOUSING PROJECTS ARE LOCATED.

WHEREAS, SP Resolution No. 16-1222-2021 was passed on December 29, 2021, granting authority to the Local Chief Executive, for and in behalf of the Provincial Government of Davao Oriental, to execute and sign a deed of absolute sale in favor of the qualified and fully-paid beneficiaries of the Provincial Socialized Housing Projects in Magsaysay, Magapo, Pahamotang, and Davao Oriental Muslim Officials and Employees Solidarity Incorporated (DORMUSOFEMS, Inc.) in Barangay Dahican, and Barangay Sainz Homeowners' Association (BASHOA), all of the City Of Mati, this province;

WHEREAS, the said SP Resolution No. 16-1222-2021 is requested to be amended by specifying the following sitios as the location of the aforementioned housing projects, to wit:

- a. Sitio Magsaysay and Sitio Magapo, all of Barangay Central
- b. Sitio Ceboley in Barangay Matiao
- c. Sitio Mapantad in Barangay Sainz

WHEREFORE, on motion of SP Member Joselito B. Villademoso, duly seconded by SP Member Ronald T. Lara, Jr., it was

RESOLVED, as it is hereby resolved, AMENDING SP RESOLUTION NO. 16-1222-2021 BY SPECIFYING THE SITIOS AND BARANGAYS WHERE THE HOUSING PROJECTS ARE LOCATED, AND THE SAME, AS AMENDED, SHALL NOW READ AS FOLLOWS:

“A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE GOVERNOR NELSON L. DAYANGHIRANG, TO EXECUTE AND SIGN A DEED OF ABSOLUTE SALE, IN FAVOR OF THE QUALIFIED AND FULLY-PAID BENEFICIARIES OF THE PROVINCIAL SOCIALIZED HOUSING PROJECTS, SPECIFICALLY IN SITIO MAGSAYSAY & SITIO MAGAPO, ALL OF BARANGAY CENTRAL, SITIO CEBOLEY IN BARANGAY MATIAO, DAVAO ORIENTAL, MUSLIM OFFICIALS AND EMPLOYEES SOLIDARITY INCORPORATED (DORMUSOFEMS, INC.) IN BARANGAY DAHICAN, AND BARANGAY SAINZ HOMEOWNERS’ ASSOCIATION (BASHOA), INCORPORATED IN SITIO MAPANTAD, BARANGAY SAINZ, ALL OF THE CITY OF MATI, DAVAO ORIENTAL.”;
