A RESOLUTION CONCURRING TO THE APPOINTMENT OF MRS. DOLORES D. VALDESCO AS PROVINCIAL GOVERNMENT DEPARTMENT HEAD OF THE ENVIRONMENT AND NATURAL RESOURCES OFFICE, PROVINCE OF DAVAO ORIENTAL, EFFECTIVE MARCH 1, 2022, PURSUANT TO SECTION 463 (D) OF REPUBLIC ACT NO. 7160 OR THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, the Provincial Governor endorsed, for concurrence by the Sangguniang Panlalawigan, the appointment of MRS. DOLORES D. VALDESCO, as the Provincial Government Department Head of the Environment and Natural Resources Office, this Province, effective March 1, 2022;

WHEREAS, Section 463 (d) of the Local Government Code provides that: *“unless otherwise provided herein, heads of departments and offices shall be appointed, among others, by the governor with the **concurrence of the majority of all sangguniang panlalawigan members**, subject to civil service law, rules and regulations”*;

WHEREAS, Section 18 Rule VI of the 2017 Omnibus Rules on Appointments and Other Human Resource Actions Revised July 2018, provides that: "xxx. *The appointing officer/authority shall submit the appointment to the local sanggunian for concurrence within seven (7) calendar days upon issuance.*";

WHEREAS, the Sangguniang Panlalawigan found the herein appointment in order that the appointee possesses all the necessary qualifications and eligibility required for the position and none of the disqualifications thereof;

WHEREFORE, on motion of SP Member Dennis V. Roflo, Jr., duly and jointly seconded by SP Members Lemuel Ian M.Larcia and Eleuterio C. Manaytay, it was

RESOLVED, as it is hereby resolved, **CONCURRING TO THE APPOINTMENT OF MRS. DOLORES D. 
