A RESOLUTION CONCURRING TO THE APPOINTMENT OF MR. JESSIE JOHN S. MADANLO AS PROVINCIAL GOVERNMENT DEPARTMENT HEAD OF THE PROVINCIAL INTERNAL AUDIT SERVICES OFFICE, PROVINCE OF DAVAO ORIENTAL, EFFECTIVE MARCH 1, 2022, PURSUANT TO SECTION 463 (D) OF REPUBLIC ACT NO. 7160 OR THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, the Provincial Governor endorsed, for concurrence by the Sangguniang Panlalawigan, the appointment of MR. JESSIE JOHN S. MADANLO as the Provincial Government Department Head of the Provincial Internal Audit Services Office, this Province, effective March 1, 2022;

WHEREAS, Section 463 (d) of the Local Government Code provides that: "unless otherwise provided herein, heads of departments and offices shall be appointed, among others, by the governor with the concurrence of the majority of all sangguniang panlalawigan members, subject to civil service law, rules and regulations";
