

DAYANGHIRANG, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE HOME **DEVELOPMENT** MUTUAL FUND (PAG-IBIG REPRESENTED BY ITS VICE PRESIDENT OF **MEMBERS SERVICES** OPERATIONS-VISAYAS/MINDANAO, RIO R. TEVES, RELATIVE TO THE IMPLEMENTATION OF THE ONLINE SHORT-TERM LOAN (STL) APPLICATION THROUGH VIRTUAL PAG-IBIG FOR THE REGULAR EMPLOYEES OF THIS PROVINCE.
