**AN ORDINANCE RENAMING THE DAVAO ORIENTAL PROVINCIAL HOSPITAL – MANAY TO CARMEN ALVAR TESHIBA PROVINCIAL HOSPITAL – MANAY, DAVAO ORIENTAL.**

**WHEREAS**, the enactment of this ordinance is for and in consideration of the request of the Honorable Governor Nelson L. Dayanghirang for a legislative action, relative to renaming the Davao Oriental Provincial Hospital-Manay to Carmen Alvar Teshiba – Davao Oriental Provincial Medical Center – Manay, in honor of the original landowner;

**WHEREAS**, the family of Ms. Atsumi T. Veradio and Mr. Andrew J. Gales, the present landowners, who donated ten thousand square meters (10,000 sq.m.) parcel of land, in favor of the Provincial Government of Davao Oriental, where the Davao Oriental Provincial Hospital-Manay currently stands, wishes that the memory of the original landowner, their late grandmother, Carmen Alvar Teshiba, be remembered and given due recognition and regard;



**WHEREAS**, in recognition for the donors' love, affection, benevolence, liberality, and selfless effort, it is fitting and appropriate to grant their wishes to promote the welfare, health, and medical care of the people of the Municipality of Manay and neighboring communities;

**WHEREAS**, Section 13 (a)(4) of R.A. 7160, otherwise known as the Local Government Code of 1991, provides that *"The sangguniang panlalawigan may, in consultation with the Philippine Historical Commission (PHC), change the name of the Provincial hospitals, health centers, and other health facilities; and paragraph (f) of the same section further provides that "A change of name of public hospitals, health centers, and other health facilities shall be made only upon the recommendation of the local health board concerned"*;

**WHEREAS**, the Provincial Health Board (PHB), through Board Resolution No. 06, series of 2021, approved the enactment of an ordinance for the change of name of Davao Oriental Provincial Hospital – Manay to Carmen Alvar Teshiba – Davao Oriental Provincial Hospital – Manay;

**WHEREFORE**, on motion of SP Member Nelson R. Dayanghirang, Jr., duly seconded by SP member Enrico M. Antopuesto, it was

Be it ordained by the 16<sup>th</sup> Sangguniang Panlalawigan of Davao Oriental in session duly assembled that:

**SECTION 1. TITLE** – This Ordinance shall be known as **"AN ORDINANCE RENAMING THE DAVAO ORIENTAL PROVINCIAL HOSPITAL – MANAY TO CARMEN ALVAR TESHIBA PROVINCIAL HOSPITAL – MANAY, DAVAO ORIENTAL"**.

**SECTION 2. OFFICIAL RECORDS AND DOCUMENTS** – All official records and documents of the Davao Oriental Provincial Hospital – Manay shall be properly changed to Carmen Alvar Teshiba – Davao Oriental Provincial Hospital – Manay, Davao Oriental.



**SECTION 3.** A copy of this Ordinance shall be forwarded to the Philippine Historical Commission, Provincial Health Board (PHB), and the Davao Oriental Provincial Hospital – Manay and the LGU of Manay, for their information and guidance.

**SECTION 4. REPEALING CLAUSE.** Any ordinance, resolutions or issuances which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SECTION 5. SEPARABILITY CLAUSE** – Should any provision declared unconstitutional or ultra vires, the rest of the provisions not so declared shall remain to be in full force and effect.

**SECTION 6. EFFECTIVITY.** This Ordinance shall take effect immediately upon approval.
