AN ORDINANCE REVERTING TO THE UNAPPROPRIATED BALANCES OF THE CY 2022 GENERAL FUND ANNUAL BUDGET, THE APPROPRIATIONS FOR SAVINGS FROM SALARIES AND OTHER COMPENSATIONS OF VARIOUS OFFICES FROM JANUARY 1 TO JUNE 30, 2022, MAINTENANCE & OTHER OPERATING EXPENSES, CAPITAL OUTLAY, PERSONAL SERVICES, OTHER LOCALLY FUNDED PPAS, LOAN PROCEEDS AND 20% LOCAL GOVERNMENT DEVELOPMENT FUNDS (LGDF) – CY 2022 CURRENT APPROPRIATIONS AND CY 2019, 2020, & 2021 CONTINUING APPROPRIATIONS; AND FURTHER AUTHORIZES ITS CORRESPONDING APPROPRIATIONS TO FUND VARIOUS PRIORITY PROGRAMS /PROJECTS/ ACTIVITIES OF THIS PROVINCE.
