**A RESOLUTION RETURNING TO THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, THE CITY ORDINANCE NO. 523, SERIES OF 2022, ENTITLED: "AN ORDINANCE INSTITUTIONALIZING THE GROUP PERSONAL ACCIDENT INSURANCE BENEFITS FOR ALL BARANGAY OFFICIALS, SK BARANGAY OFFICIALS, BARANGAY FUNCTIONARIES OF THE CITY OF MATI, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES", WITHOUT ACTION, PENDING CLARIFICATION IN RELATION TO REPUBLIC ACT 6942 AND SECTION 393 OF REPUBLIC ACT 7160.**

**WHEREAS**, SP Secretary Juvy L. Mabini of the City of Mati submitted to this Sangguniang Panlalawigan, for review, the City Ordinance No. 523, series of 2022, entitled: "*An ordinance institutionalizing the Group Personal Accident Insurance Benefits for all barangay officials, SK barangay officials, barangay functionaries of the City of Mati, appropriating funds therefor and for other purposes*";

**WHEREAS**, the reasons for enacting City Ordinance No. 523-2022 explained hereunder, quote:

**WHEREAS**, our barangay officials, SK officials, and barangay functionaries are always at the forefront in so far as public service is concern as they are based in the community, thus are always prone to accidents and troubled;

**WHEREAS**, some of them had died in the line of duty but they **RECEIVED NOTHING** because **THEY DO NOT HAVE ANY INSURANCE** to cover such death, or some of them had been hospitalized and suffer the burden of paying their bills, without any benefit from the government; unquote xxx

**WHEREAS**, Section 4 thereof provided for “Insurance Benefits – There is hereby established an insurance for Barangay Officials, SK Officials, and Barangay Functionaries who have rendered services in their respective barangays”;

**WHEREAS**, Section 6 thereof provides for “Administration of Funds – The Kilos Barangay shall administer and ensure the appropriate disbursement of the fund”;

**WHEREAS**, after a careful review of the Committee on Finance, Budget & Appropriations to which the subject City Ordinance was referred, it is recommended to return the same without action pending submission of reply to the following queries/concerns:

1. *Whether the Insurance Benefits cited in Section 4 of the Ordinance, is a new, special or additional benefits granted to Barangay Officials and Functionaries of the City of Mati?*
2. *Whether existing insurance benefits granted to Barangay Officials provided under Section 2 of RA 6942 and Section 393 (b)(2) of RA 7160 respectively, no longer in effect as cited in the prefatory statement or preamble of the Ordinance, quoted hereunder:*

*WHEREAS, some of them had died in the line of duty but they received nothing because they do not have any insurance to cover such death, or some of them had been hospitalized and suffer the burden of paying their bills, without any benefit from the government; unquote xxx*

3. *Whether **The Kilos Barangay** who is designated to administer and disburse insurance premiums provided in Section 6 thereof does not usurp, duplicate or encroach to the functions of existing government offices or departments of the City government?*
4. *Whether the provision of Section 6 of the Ordinance not inconsistent with Section 11 of COA Circular No. 92-382?*

**WHEREFORE**, on motion of SP Member Anacleto P. Macatabog, unanimously seconded by all members present, it was

**RESOLVED**, as it is hereby resolved, RETURNING TO THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, THE CITY ORDINANCE NO. 523, SERIES OF 2022, ENTITLED: “AN ORDINANCE INSTITUTIONALIZING THE GROUP PERSONAL ACCIDENT INSURANCE BENEFITS FOR ALL BARANGAY OFFICIALS, SK BARANGAY OFFICIALS, BARANGAY FUNCTIONARIES OF THE CITY OF MATI, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES”,


