

A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR NELSON L. DAYANGHIRANG, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH — DAVAO CENTER FOR HEALTH DEVELOPMENT, REPRESENTED BY ITS REGIONAL DIRECTOR, DR. ANNABELLE P. YUMANG, MD, MCH, CESO III, FOR THE MEAL, ACCOMMODATION, AND TRANSPORTATION (MAT) BENEFITS AS CASH EQUIVALENT TO PUBLIC AND PRIVATE HEALTH CARE WORKERS (HCWS) FOR THE PERIOD COVERED FROM SEPTEMBER 15 TO DECEMBER 19, 2020, AMOUNTING TO THREE MILLION THREE HUNDRED FIFTY-THREE THOUSAND PESOS (P3,353,000.00);

WHEREAS, pursuant to the provisions of Chapter 3, Section 465(b)(1)(vi) of the Local Government Code of 1991, the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan or pursuant to law or ordinance;
