

A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR NELSON L. DAYANGHIRANG, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA), WITH DR.
