A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE GOVERNOR NELSON L. DAYANGHIRANG, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO NEGOTIATE AND ENTER INTO A CONTRACT OF ABSOLUTE SALE, FOR THE PURCHASE OF A PARCEL OF LAND CONTAINING AN AREA OF 19,827 SQUARE METERS, SITUATED AT BARANGAY PUNTALINAO, MUNICIPALITY OF BANAYBANAY, DAVAO ORIENTAL, TO BE USED AS RELOCATION SITE, SUBJECT TO THE EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO.

WHEREAS, the Provincial Appraisal Committee (PAC) conducted an ocular inspection, verification, and appraisal of the Real Property registered under the name of Nicomedes Barros, covered by Lot. No. 4651, Cad-353-D, in which the Local Government Unit has the intent to purchase, to be utilized as a relocation site for the indigent families situated at Sitio Dinagsaan, Barangay Puntalinao, Municipality of Banaybanay, Davao Oriental, and thereby recommended the fair market value at the price of Six Hundred Fifty Two Thousand Three Hundred Eight (Php 652,308.00) Pesos, for the entire area of 19,827 square meters, more or less, including all the improvements thereon;






