DAYANGHIRANG, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE DEPARTMENT OF HEALTH – DAVAO CENTER FOR HEALTH DEVELOPMENT, REPRESENTED BY ITS REGIONAL DIRECTOR, DR. ANNABELLE P. YUMANG, MCH, CESO III, AND DAVAO ORIENTAL PROVINCIAL HOSPITAL – GOVERNOR GENEROSO, REPRESENTED BY ITS CHIEF OF HOSPITAL, DR. KARISSA MAY S. 
