Province-Led Agriculture and Fishery Extension System (PAFES), and will provide financial assistance to Davao Oriental State University (DOrSU) in the amount of **ONE MILLION (P1,000,000.00) PESOS**;

WHEREAS, the DOrSU shall utilize the funds provided to fully conduct the Rapid Appraisal to assess the resources and capabilities of the Local Government Unit in providing Agriculture and Fisheries Extension Services;

WHEREAS, the Agriculture Training Institute (ATI) and the Bureau of Fisheries and Aquatic Resources (BFAR) shall provide the necessary technical assistance and capability building support to the LGU, in collaboration with the DA and DOrSU;
