**A RESOLUTION ADOPTING EXECUTIVE ORDER NO. 12, SERIES OF 2022, ISSUED BY THE HONORABLE GOVERNOR NELSON L. DAYANGHIRANG OF THIS PROVINCE, RE: "AN ORDER CREATING THE 2022 PROVINCIAL GOVERNANCE TRANSITION TEAM (PGTT)", IN COMPLIANCE WITH MEMORANDUM CIRCULAR NO. 2022-029, DATED MARCH 10, 2022, BY THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG).**

**WHEREAS**, Executive Order No. 12, series of 2022, was issued on the 23<sup>rd</sup> day of March 2022, by the Honorable Governor Nelson L. Dayanghirang, purposely to ensure smooth local governance transition to a new set of elected local officials on June 30, 2022;

**WHEREAS**, Memorandum Circular No. 2022-029, dated March 10, 2022, issued by the Department of the Interior and Local Government (DILG), states that: "All Provincial Governors, City Mayors, and Municipal Mayors are required to create a Local Governance Transition Team in their respective Local Government Units (LGUs) not later than April 7, 2022";
