WHEREAS, the Provincial Governor endorsed, for concurrence by the Sangguniang Panlalawigan, the appointment of MS. ROSAFEL C. BATINGANA, as the Provincial Government Department Head of the Provincial Cooperative's Office, this Province, effective March 24, 2022;
