A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE GOVERNOR NELSON L. DAYANGHIRANG, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA), WITH THE OFFICE OF THE PRESIDENT, REPRESENTED BY ITS EXECUTIVE SECRETARY, SALVADOR C. MEDIALDEA, RELATIVE TO THE ALLOCATION AND TRANSFER OF FIFTY MILLION (P50,000,000.00) PESOS TO THE DAVAO ORIENTAL PROVINCIAL MEDICAL CENTER (DOPMC), TO BE SOURCED FROM THE OFFICE OF THE PRESIDENT’S SOCIO-CIVIC PROJECTS FUND (SCPF), THE SAME BE MADE AVAILABLE FOR PRESCRIPTION MEDICINES, MEDICAL SUPPLIES/DEVICES AND DIAGNOSTIC TESTS, AND OTHER HOSPITAL CARE MEDICAL SERVICES AND SUPPORT TO INDIGENT, VULNERABLE, AND DISADVANTAGED PATIENTS;

WHEREAS, pursuant to the provisions of Chapter 3, Section 465 (b)(1)(vi) of the Local Government Code of 1991, the Provincial Governor shall “*represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan or pursuant to law or ordinance*”;

WHEREFORE, on motion of SP Member Enrico M. Antopuesto, duly seconded by SP Member Rustan R. Castellones, it was

RESOLVED, as it is hereby resolved, **GRANTING AUTHORITY TO THE HONORABLE GOVERNOR NELSON L. DAYANGHIRANG, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA), WITH THE OFFICE OF THE PRESIDENT, REPRESENTED BY ITS EXECUTIVE SECRETARY, SALVADOR C.
