A RESOLUTION INTERPOSING NO OBJECTION ON THE APPLICATION OF TQGT MINERAL RESOURCES DEVELOPMENT CORP. FOR A DECLARATION OF MINING PROJECT FEASIBILITY (DMPF), COVERING BARANGAY LUBAN OF THE CITY OF MATI AND BARANGAY TIBLAWAN OF THE MUNICIPALITY OF GOVERNOR GENEROSO, BOTH OF THE PROVINCE OF DAVAO ORIENTAL, WITH EXPLORATION PERMIT NO. 000001-2019-XI, PROVIDED THAT ALL OTHER GOVERNMENT REQUIREMENTS RELEVANT THEREOF SHALL BE COMPLIED WITH.

WHEREAS, a letter dated May 2, 2022 from TQGT Mineral Resources Development Corp., signed by its Corporate Secretary, Ms. Prescy M. Olden, addressed to the Honorable Governor thru the Honorable Vice Governor requesting for a Sangguniang Panlalawigan resolution for the above mentioned subject matter was received by the SP Support Services Office last May 19, 2022;

WHEREAS, the Sangguniang Barangay of Luban, and the Sangguniang Panlungsod of the City of Mati, have passed and approved respective resolutions interposing no objection to the application of TQGT Mineral Resources Development Corp. for Declaration of Mining Project Feasibility (DMPF) through Sangguniang Barangay Resolution No. 009, series of 2022, and Sangguniang Panlungsod Resolution No. 39, series of 2022, respectively;

WHEREAS, the Sangguniang Barangay of Tiblawan of the Municipality of Governor Generoso, likewise passed and approved a resolution interposing no objection to the application of TQGT Mineral Resources Development Corp. for Declaration of Mining Project Feasibility (DMPF) in their area of jurisdiction through Sangguniang Barangay Resolution No. 01, series of 2022;

WHEREAS, Section 8 (a) of Republic Act No. 7942, otherwise known as the "Philippine Mining Act of 1995", provides among others, that: *"the Local Government Units (LGUs) shall ensure that relevant laws on public notice, public consultation and public participation on mining projects within their respective jurisdictions is complied with"*;

WHEREAS, in the exercise of the powers expressly granted by law, as defined under Section 16 and Section 468 (a) of Republic Act 7160, otherwise known as the Local Government Code of 1991, this August Body has conscientiously reviewed all documentary requirements submitted in consultation with government technical agencies, barangays, and municipal/city stakeholders, with due diligence have found no legal impediment to grant the request;

WHEREFORE, on motion of SP Member Louis N. Rabat, duly seconded by SP Member Rabsalon M. Lamarin, it was

RESOLVED, as it is hereby resolved, **INTERPOSING NO OBJECTION ON THE APPLICATION OF TQGT MINERAL RESOURCES DEVELOPMENT CORP. FOR A DECLARATION OF MINING PROJECT FEASIBILITY (DMPF), COVERING BARANGAY LUBAN OF THE CITY OF MATI AND BARANGAY TIBLAWAN OF THE MUNICIPALITY OF GOVERNOR GENEROSO, BOTH OF THE PROVINCE OF DAVAO ORIENTAL, WITH EXPLORATION PERMIT NO. 000001-2019-XI, PROVIDED THAT ALL OTHER GOVERNMENT REQUIREMENTS RELEVANT THEREOF SHALL BE COMPLIED WITH;**


