A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 05-2021, SERIES OF 2021, OF THE MUNICIPALITY OF CATEEL, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 05-2021, of the Municipality of Cateel, Davao Oriental, authorizing its CY 2022 General Fund Annual Budget, involving the total appropriation of <a href="https://doi.org/10.1001/jhtml.com/">Three Hundred Five Million Pesos (P305,000,000.00)</a>, was submitted to this Sanggunian for review on December 29, 2021, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

**WHEREFORE**, on motion of SP Member Anacleto P. Macatabog, duly and jointly seconded by SP Members Ronald T. Lara, Jr., Enrico M. Antopuesto, and Dante M. Caubang, it was

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 05-2021, of the Municipality of Cateel, Davao Oriental, **OPERATIVE IN ITS ENTIRETY**, as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

- 1. The computation on Personal Services Limitations shall be in accordance with Local Budget Circular No. 145, dated March 2, 2022;
- 2. The appropriation for 20% Development Fund shall be in accordance with the approved CY 2022 Annual Investment Program (AIP)/Development Plan, pursuant to Sections 287 and 305 (i) of RA 7160; DILG Memorandum Circular No. 2004-130, dated October 1, 2004; DILG-NEDA-DBM-DOF JMC No. 1, dated November 18, 2016; and DILG-DBM JMC No. 2017-1, dated February 22, 2017. Development projects should contribute to the attainment of desirable socio-economic development and environmental outcomes and should partake the nature of investment or capital expenditures;
- 3. The utilization of LDRRM Fund in the General Fund shall be subject to Section 324 (d) of RA 10121 and its implementing rules and regulations, pursuant to NDRRMC-DBM-DILG JMC No. 2013-1, dated March 25, 2013, and other laws, rules and regulations governing the same. Further, 70% of the 5% LDRRMF shall be supported with LDRRMP. It is understood that the LDRRMP shall be reviewed by the appropriate reviewing authority pursuant to Local Budget Memorandum No. 78, dated May 15, 2019;
- 4. The GAD Plan and Budget shall be duly reviewed and endorsed by the DILG, pursuant to the provisions of PCW-DILG-NEDA-DBM JMC No. 2016-01, dated January 12, 2016; implementing RA No. 9710 or the Magna Carta of Women; and RA 7192 or Women in Development and Nation Building Act;
- 5. The appropriation for Confidential Fund shall not exceed thirty percent (30%) of the total annual amount allocated for the LGUs POP, pursuant to be in accordance with DBM-DILG-DND-GCG and COA Joint Circular No. 2015-01, dated January 8,2015;
- No PPAs shall be funded in the Annual and/or Supplemental Budgets if it is not included and/or in accordance with the Approved Annual and/or Supplemental Investment Program, pursuant to Section 305 (i) of RA 7160;
- 7. It is understood that appropriations for basic services and facilities of the municipality, including those for devolved functions, are provided,

pursuant to Article 25 of the Rules and Regulations, implementing the Local Government Code of 1991;

8. Implementation of PPAs of Municipal Council for the Protection of Children (MCPC) shall be in accordance with DILG Memorandum Circular No. 2012-120 dated July 4, 2012.

**RESOLVED FURTHER**, to inform the Municipality of Cateel, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

**RESOLVED FINALLY,** to send a copy of this Resolution to the Sangguniang Bayan of Cateel, Davao Oriental, through the Municipal Mayor.
