A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 88, SERIES OF 2021, OF THE MUNICIPALITY OF BOSTON, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 88, series of 2021, of the Municipality of Boston, Davao Oriental, authorizing its CY 2022 General Fund Annual Budget, involving the total appropriation of One Hundred Ninety Two Million Six Hundred Sixty Eight Thousand Nine Hundred Forty Nine Pesos (P 192,668,949.00), was submitted to this Sanggunian for review on January 12, 2022, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

WHEREFORE, on motion of SP Member Anacleto P. Macatabog, duly and jointly seconded by SP Members Ronald T. Lara, Jr., Enrico M. Antopuesto, and Dante M. Caubang, it was

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 88, series of 2021, of the Municipality of Boston, Davao Oriental, **OPERATIVE IN ITS ENTIRETY**, as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to previous recommendation that the LGU shall adopt measure by way of partially implementing salary compensation, also the no filling-up of vacant funded positions except for mandatory one, in order to reduce the aforesaid excess in the amount equivalent to that which is within the exact 45% limitation, pursuant to DBM Local Budget Circular No. 98, dated October 14, 2011, and Executive Order No. 201, series of 2016, dated February 19, 2016;

RESOLVED FURTHER, to inform the Municipality of Boston, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Boston, Davao Oriental, through the Municipal Mayor.
