**RESOLVED**, to declare Appropriation Ordinance No. 1-2022 of the Municipality of Cateel, Davao Oriental, **OPERATIVE IN ITS ENTIRETY**, as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the condition that the grant of Service Recognition Incentive (SRI) in the total amount of P1,190,000.00 and Gratuity Pay to Contract of Service and Job Order Workers in the government in the amount of P915,000.00 for FY 2021, shall be in accordance with Administrative Order No. 45 and 46, dated December 28 and 29, 2021, respectively.

**RESOLVED FURTHER,** to inform the Municipality of Cateel, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

**RESOLVED FINALLY,** to send a copy of this Resolution to the Sangguniang Bayan of Cateel, Davao Oriental, through the Municipal Mayor.
