RESOLVED, to declare Appropriation Ordinance No. 001-16-2022, of the Municipality of San Isidro, Davao Oriental, **OPERATIVE IN ITS ENTIRETY**, as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the relevant provision under the Budget Operation Manual for Local Government Units issued under Local Budget Circular No. 112, dated June 10, 2016, in relations to Section 56(a) and 327 of RA 7160, and Article 110 of its Implementing Rules and Regulations (IRR), which requires that: "Within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said ordinance to the Department of Budget and Management or Sangguniang Panlalawigan for review".

RESOLVED FURTHER, to inform the Municipality of San Isidro, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of San Isidro, Davao Oriental, through the Municipal Mayor.
