A RESOLUTION INTERPOSING NO OBJECTION TO THE CONVERSION OF THE MATI – MANAY ROAD TRAVERSING ALONG JUNCTION NATIONAL HIGHWAY SURIGAO DEL SUR BOUNDARY – DAVAO ORIENTAL COASTAL ROAD, KM 1655 + 300 – KM 1691 + 120 LEADING TO DIOMABOC LAKE AND ENDING UP TO BOUNDARY OF DAVAO ORIENTAL 2ND DISTRICT INTO A NATIONAL ROAD.

WHEREAS, DPWH – 1st Engineering District, through Engr. Cirilo M. Lasaca, District Engineer, requested the Honorable Governor Nelson L. Dayanghirang, for the passage of a resolution from this Sangguniang Panlalawigan, relative to the abovementioned subject matter;

WHEREAS, the proposed road conversion supports the Provincial Development Agenda in order to expand the access to infrastructure, utilities, and social services;

WHEREAS, Provincial Development Council Executive Committee has passed and approved PDC-EXCOM Resolution No. 6, series of 2022, dated May 6, 2022, entitled: **“A RESOLUTION INTERPOSING NO OBJECTION TO THE CONVERSION OF THE MATI – MANAY ROAD TRAVERSING ALONG JUNCTION NATIONAL HIGHWAY SURIGAO DEL SUR BOUNDARY – DAVAO ORIENTAL COASTAL ROAD, KM 1655 + 300 – KM 1691 + 120 LEADING TO DIOMABOC LAKE AND ENDING UP TO BOUNDARY DAVAO ORIENTAL 2ND DISTRICT INTO A NATIONAL ROAD AND ENDORSING THE SAME TO THE SANGGUNIANG PANLALAWIGAN (SP), THIS PROVINCE, FOR ITS APPROPRIATE ACTION”**;




