A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 05, SERIES OF 2021, OF THE MUNICIPALITY OF GOVERNOR GENEROSO, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 05, series of 2021, of the Municipality of Governor Generoso, Davao Oriental, authorizing its CY 2022 General Fund Annual Budget, involving an appropriation of
Three Hundred Twenty Six Million Five Hundred Forty Eight Thousand Three Hundred Ninety Four Pesos (P 326,548,394.00)">326,548,394.00), was submitted to this Sanggunian for review on April 8, 2022, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

WHEREFORE, on motion of SP Member Marietta D. Palmera, duly and jointly seconded by SP Members Anna Cheryl N. Castro, Shella Marie S. Go, Harold A. Montes, Rotchie M. Ravelo, Stephen Paul L. Uy, Rustan R. Castillones and Eleuterio C. Manaytay, it was

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 05, series of 2021, of the Municipality of Governor Generoso, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

- a. Reiterating previous recommendation that the LGU shall adapt measure by not filling-up of vacant funded positions except for mandatory one, and no creation of positions, in order to reduce the aforesaid excess in the amount equivalent to that which is within the exact 45% limitation, pursuant to DBM LBC No. 98, dated October 14, 2011 and Executive Order No. 201, s. 2016, dated February 19, 2016;
- b. Implementation of PPAs pertaining to Gender and Development shall be in accordance with PCW-DILG-NEDA-DBM JMC No. 2016-01, dated January 12, 2016 implementing RA 9710 or the Magna Carta for Women, RA 7192 or Women in Dev't. and Nation Bldg. Act. The deficit amount of <u>P4,207,739.70</u> shall be provided in the very next supplemental budget;
- c. Implementation of PPAs for the Senior Citizens and Persons with Disability shall conform with DBM-DSWD JC No. 2003-01, dated April 28, 2003, pursuant to RA No. 9994, amending RA No. 7277. The deficit amount of P1,900,483.94 shall be provided in the very next supplemental budget.

RESOLVED FURTHER, to inform the Municipality of Governor Generoso, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

MOREOVER, The Local Government Unit is reminded of the relevant provision under the Budget Operation Manual for Local Government Units issued under Local Budget Circular No. 112, dated June 10, 2016 in relation to Sections 56(a) and 327 of RA 7160, and Article 110 of its Implementing Rules and Regulations (IRR) which requires that, "Within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said ordinance to the Department of Budget and Management or Sangguniang Panlalawigan for review."

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Governor Generoso, Davao Oriental through the Municipal Mayor.
