WHEREAS, as mandated by law, pursuant to Sec. 480(a) of R.A. 7160 stated among others, *“the term of the Provincial Administrator is coterminous with that of his appointing authority, the Provincial Governor”*;

WHEREAS, Section 463(d) of the Local Government Code provides among others that: *“the heads of department and offices shall be appointed by the governor with the concurrence of the majority of all sangguniang panlalawigan members, subject to civil service law, rules and regulations”*;

WHEREAS, Section 18 Rule VI of the 2017 Omnibus Rules on Appointments and Other Human Resource Actions Revised July 2018, provides that: *“xxx. The appointing officer/authority shall submit the appointment to the local sanggunian for concurrence within seven (7) calendar days upon issuance”*;

WHEREAS, the Sangguniang Panlalawigan found the same in order, and that the appointee possesses all the necessary qualifications and eligibility required for the position;
