EXECUTIVE ORDER NO. 4

**AN ORDER RECONSTITUTING THE COMPOSITION OF THE LOCAL FINANCE COMMITTEE (LFC)
OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL**

WHEREAS, Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provided for the creation of the Local Finance Committee in every local government unit;

WHEREAS, the need to reconstitute the composition of the Committee becomes imperative to further assist and advise the Governor in addressing budgetary and other fiscal matters;

NOW THEREFORE, by the powers vested in me by law, I, **CORAZON N. MALANYAON**, Provincial Governor, do hereby ORDER/DIRECT the reconstitution of the Local Finance Committee (LFC) and its Secretariat, and define its composition, duties and functions.

Section 1: Composition of the Local Finance Committee

Section 2: Duties and Responsibilities of the LFC

The LFC shall exercise the following:

- a. Shall perform duties and responsibilities set forth under the R.A. 7160;
- b. Assist the Governor in all activities to generate revenue sources for the general welfare of the local populace;
- c. Formulate and recommend to the Governor for the approval of the revenue generating policies, implementing guidelines and strategies, and applicable methods to ably attain objectives;

Section 3: Composition of Secretariat

There shall be constituted a Secretariat which shall be responsible for providing technical supports and documentation, to assist in the advocacy on strategic direction for more effective revenue generation, preparation of reports and such other assistance as may be required in the discharge of its functions, namely:

Section 4: Meetings

The Committee shall conduct its regular meeting every 2nd and 4th Thursday of the month without prejudice to having meetings on a need basis.

Section 5: Honoraria

Corollary to the foregoing, the LFC members and its Secretariat shall be entitled to receive honoraria and/or other incentives, subject to the usual accounting and auditing rules and regulations, as follows:

▪ Members and Head Secretariat	- P7,000.00/month
▪ Secretariat	- P5,000.00/month

Section 6: Repealing Clause

This Executive Order (EO) repeals, amends, and/or modifies all previous issuances and orders inconsistent herewith accordingly.

Section 7: Effectivity

The Executive Order shall take effect immediately.
