EXECUTIVE ORDER NO. 8 s. 2022

AN ORDER RECONSTITUTING THE COMPOSITION OF THE SEAL OF GOOD LOCAL GOVERNANCE - LOCAL GOVERNANCE PERFORMANCE MANAGEMENT SYSTEM (SGLG-LGPMs) TEAM OF DAVAO ORIENTAL AND ITS FOCAL PERSONS

WHEREAS, SGLG-LGPMs as a self-assessment tool to assess performance and state of development, using sets of questions (indicators) to gather raw data from local governments;

WHEREAS, SGLG-LGPMs is a performance management tool that helps identify development gaps and further guides local government units to develop executive and legislative actions to address such gaps;

WHEREAS, it is called self-assessment since respondents are local government officials and functionaries themselves wherein an artificial intelligence on the interpretation of results is embedded in the system that uses a benchmark and scaling system to measure performance and state of development;

WHEREAS, two benchmarks are used, External Benchmark and Internal Benchmark, wherein External Benchmark is utilized to compare and appraise local government performance and state of development based on standards, national average or targets while Internal Benchmark is used to evaluate current year performance as compared to performance in previous years;

WHEREAS, in keeping with the notion of progressively measuring local governance performance in the Seal, indicators are up scaled regularly through upgrading other attributes, expanding membership, increasing targets and adding new indicators.

NOW, THEREFORE, I, CORAZON T. NUÑEZ-MALANYAON, Provincial Governor, by virtue of the power vested in me by law, do hereby order the reconstitution of the Seal of Good Local Governance - Local Governance Performance Management System (SGLG - LGPMs) Team of Davao Oriental and its Focal Persons.

SECTION 1. CREATION. Expanding hereby the Local Governance Performance Management System-Local Government Unit (LGPMs-LGU) Team for the Province of Davao Oriental.

SECTION 2. COMPOSITION OF SGLG-LGPMs TEAM. The team shall be composed of the following:

SECTION 3. FUNCTIONS OF SGLG – LGPMS Team. The team shall have the following roles and responsibilities to wit:

1. Provide data or information on the indicators.
2. Facilitate the linking of results to planning and budgeting, and other desired actions whether legislative or executive.
3. Facilitate in the preparation of required documents in relation to policy and program development actions.
4. Conduct meetings/forum for discussion relevant to the system and its outcome.

SECTION 4. COMPOSITION OF SGLG – LGPMS FOCAL PERSONS. There shall be constituted ten (10) Focal Persons for all areas under the Annual SGLG Assessment, namely:

1. Financial Administration - Ms. Jeannete C. Te, PACSO
2. Disaster Preparedness - Mr. Al Jamil A. Macatabag, PDRRM/O
3. Social Protection and Sensitivity - Ms. Fedelina B. Iris, PSWDO and Ms. Aileen Ponce, SP
4. Health Compliance & Responsiveness – Ms. Rizza Jean R. Rivera, PHO
5. Sustainable Education - Ms. Josephine Lastrado, DepEd
6. Business-Friendliness and Competitiveness – Mr. Carmelito Laburada, C-Point
7. Safety, Peace & Order - Ms. Marjorie T. Egot, PUDO
8. Environmental Management - EnP Leo Gene Solamo, ENRO
9. Tourism, Heritage Development, Culture & the Arts - Ms. Maribeth Villaceran, Tourism and Mr. Mark Kevin Campos, Tourism
10. Youth Development - Mr. Van Jorain O. Rufin, PYDO

SECTION 5. FUNCTIONS OF SGLG – LGPMS FOCAL PERSONS.

1. Responsible in gathering the required documents per area.
2. In-charge in the compilation of requirements (both hard and electronic copies) as required by DILG.
3. Prepare other documents and/or site as requirements relative to the assessment.


SECTION 6. SCHEDULE OF MEETING. The Local Governance Performance Management System-Local Government Unit Team (SGLG – LGPMS) shall meet as often as necessary and when major issues and concerns need to be addressed immediately.

SECTION 7. SECRETARIAT. There shall be a SGLG Focal headed Ms. Evelyn Viluz M. Pabio, PEO IV of the Provincial Planning & Development Office which shall be responsible in facilitating the SGLG requirements of all concerned for submission to DILG, provide technical support, and such other assistance as maybe required in the discharge of its functions.

SECTION 8. BUDGET. The Provincial Government shall allocate funds for the activities of the SGLG-LGPMs Team chargeable against the LGDF/General Fund. Other sources of funds may also be mobilized for this purpose.

SECTION 9. EFFECTIVITY. This order shall take effect immediately.
