A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 01-2022, OF THE SANGGUNIANG BAYAN OF CATEEL, DAVAO ORIENTAL, RE: "PROMOTING AGRICULTURAL AND FISHERIES MECHANIZATION AND DEVELOPMENT IN THE MUNICIPALITY OF CATEEL, DAVAO ORIENTAL, AND PROVIDING FUNDS AND PENALTIES THEREOF", SUBJECT TO EXISTING RULES, LAWS AND REGULATIONS RELATIVE THERETO.

WHEREAS, pursuant to Republic Act. No. 10601, otherwise known as the "Agricultural and Fisheries Mechanization (AFMech) Law", under Section 2(a) – "It shall be the policy of the State to promote the development and adoption of modern, appropriate and cost-effective and environmentally-safe agricultural and fisheries machinery and equipment to enhance farm productivity and efficiency in order to achieve food security and safety and increase farmers' income";

WHEREAS, Section 19 - Registration of Ownership of Agricultural and Fishery Machinery and Equipment, of the same Act, states that: *“All owners of agricultural and fishery machinery and equipment must register these with the agriculture offices of municipal and city government units xxx”*;

WHEREAS, Municipal Ordinance No. 01-2022 was enacted by the Sangguniang Bayan of Cateel, on the 7th day of June, 2022, purposely to provide owners and the Municipal Government of Cateel, Davao Oriental, a framework for implementing the registration of agriculture and fisheries machinery and equipment;

WHEREAS, Section 468(a)(1)(i) of Republic Act No. 7160, states that: *“The sangguniang panlalawigan as the legislative body of the province, shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor”*;

WHEREFORE, on motion of SP Member Harold A. Montes, duly and jointly seconded by SP Members Anna Cheryl N. Castro, Stephen Paul L. Uy, Andy A. Monday, an Art Benjie C. Bulaong, it was

RESOLVED, as it is hereby resolved, **CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 01-2022, OF THE SANGGUNIANG BAYAN OF CATEEL, DAVAO ORIENTAL, ENTITLED: “PROMOTING AGRICULTURAL AND FISHERIES MECHANIZATION AND DEVELOPMENT IN THE MUNICIPALITY OF CATEEL, DAVAO ORIENTAL, AND PROVIDING FUNDS AND PENALTIES THEREOF”**, SUBJECT TO EXISTING RULES, LAWS AND REGULATIONS RELATIVE THERETO;
