A RESOLUTION RETURNING TO THE SANGGUNIANG PANLUNGSOD OF OF MATI, DAVAO ORIENTAL, THE HEREIN CITY ORDINANCE NO. 534, SERIES OF 2022, ENTITLED: "AN ORDINANCE RETITLING THE POSITION OF NUTRITIONIST / DIETITIAN III (SG 18) ITEM NO. 201011-3 TO NUTRITION OFFICER III (SG 18) AND CREATING TWO (2) FUMIGATOR (SG 4) OF THE CITY HEALTH OFFICE, THIS CITY", WITHOUT ACTION, SUBJECT FOR THEIR REVIEW AND APPROPRIATE ACTION THEREOF.

WHEREAS, Mr. Juvy L. Mabini, SP Secretary of the City of Mati, Davao Oriental, in his letter, dated July 13, 2022, has forwarded City Ordinance No. 534, series of 2022, to the Sangguniang Panlalawigan of Davao Oriental, for review;

**WHEREAS**, the subject City Ordinance was referred to the Committee on Labor and Employment, Civil Service & Human Resource Development on July 20, 2022, during the 3<sup>rd</sup> Regular Session of the 17<sup>th</sup> Sangguniang Panlalawigan;

WHEREAS, the said Ordinance was enacted by the Sangguniang Panlungsod on June 14, 2022;

WHEREAS, in exercising the prescribed functions of the Sangguniang Panlalawigan to review all ordinances approved by the Sanggunians of component cities and municipalities to determine whether these are within the scope of the prescribed powers of the Sanggunians, among others, the Committee found that one of the provisions stated in the subject Ordinance is abolition of two (2) Fumigator Supervisors (SG 11);

**WHEREAS**, the said provision is found to be inconsistent to the Ordinance's title, which only provides for the retitling and creation of various positions, thus, the need to return the said subject matter to the concerned Sanggunian is deemed proper for their further review and appropriate action;

WHEREFORE, on motion of SP Member Marietta D. Palmera, duly and jointly seconded by SP Members Rotchie M. Ravelo, Andy A. Monday, Stephen Paul L. Uy, and Art Benjie C. Bulaong, it was
