A RESOLUTION RETURNING TO THE SANGGUNIANG BAYAN OF GOVERNOR GENEROSO, DAVAO ORIENTAL, THE HEREIN MUNICIPAL ORDINANCE NO. 13, SERIES OF 2022, ENTITLED: "AN ORDINANCE CREATING THE POSITION OF RESEARCH AND PLANNING OFFICER (LDRRMO I), SALARY GRADE 11 FOR THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE OF GOVERNOR GENEROSO, DAVAO ORIENTAL.", WITHOUT ACTION, SUBJECT FOR THEIR REVIEW AND APPROPRIATE ACTION THEREOF.

WHEREAS, Mr. Val E. Amigo, SB Secretary of Governor Generoso, Davao Oriental, in his letter, dated July 13, 2022, has forwarded Municipal Ordinance No. 13, series of 2022, for review and approval of this Sangguniang Panlalawigan;

WHEREAS, the subject Municipal Ordinance was referred to the Committee on Labor and Employment, Civil Service & Human Resource Development on July 20, 2022, during the 3rd Regular Session of the 17th Sangguniang Panlalawigan;

WHEREAS, the said Ordinance was enacted by the Sangguniang Bayan on June 14, 2022, and was approved by the Municipal Mayor on June 29, 2022;

WHEREAS, in exercising the prescribed functions of the Sangguniang Panlalawigan to review all ordinances approved by the Sanggunians of component cities and municipalities to determine whether these are within the scope of the prescribed powers of the sanggunians, among others, the Committee finds some inconsistencies in the Ordinance, specifically on the following:

1. The created position is *RESEARCH AND PLANNING OFFICER* instead of LOCAL DRRM OFFICER I; and
2. The third paragraph states that: "*Whereas, an additional employee at the Municipal Mayor's Office, this municipality, is indispensable in lessening the workloads of the current personnel of the said office and its clientele will be properly attended*";

WHEREAS, the abovementioned findings are inconsistent to the Ordinance title and not in conformity with the prescribed title pursuant to NDRRMC-DILG-DBM-CSC Joint Memorandum Circular No. 2014-1, dated April 4, 2014;

WHEREAS, there is a need to return to the concerned Sangguniang Bayan, the subject Municipal Ordinance, for their review and appropriate action thereof;

WHEREFORE, on motion of SP Member Marietta D. Palmera, duly and jointly seconded by SP Members Rotchie M. Ravelo, Andy A. Monday, Stephen Paul L. Uy, and Art Benjie C. Bulaong, it was

RESOLVED, as it is hereby resolved, **RETURNING TO THE SANGGUNIANG BAYAN OF GOVERNOR GENEROSO, DAVAO ORIENTAL, THE HEREIN MUNICIPAL ORDINANCE NO. 13, SERIES OF 2022, ENTITLED: "AN ORDINANCE CREATING THE POSITION OF RESEARCH AND PLANNING OFFICER (LDRRMO I), SALARY GRADE 11 FOR THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE OF GOVERNOR GENEROSO, DAVAO ORIENTAL."**, WITHOUT ACTION, SUBJECT FOR THEIR REVIEW AND APPROPRIATE ACTION THEREOF.
