

A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 12, SERIES OF 2022, OF THE SANGGUNIANG BAYAN OF GOVERNOR GENEROSO, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE CREATING THE POSITION OF ADMINISTRATIVE AIDE IV (DRIVER II), SALARY GRADE 4 FOR THE MUNICIPAL MAYOR'S OFFICE, THIS MUNICIPALITY", CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN PURSUANT TO ARTICLE III, SECTION 447(a)(1) OF R.A 7160, OR THE LOCAL **GOVERNMENT CODE OF 1991.**

WHEREAS, Mr. Val E. Amigo, SB Secretary of Governor Generoso, Davao Oriental, in his letter dated July 13, 2022, has forwarded Municipal Ordinance No. 12, Series of 2022, for review and approval of this Sangguniang Panlalawigan;

WHEREAS, the subject Municipal Ordinance was referred to the Committee on Labor and Employment, Civil Service & Human Resource Development on July 20, 2022, during the 3rd Regular Session of the 17th Sangguniang Panlalawigan;

WHEREAS, the subject Ordinance was enacted by the Sangguniang Bayan on June 14, 2022, and was approved by the Municipal Mayor on June 29, 2022;

WHEREAS, in exercising the review functions of the Sangguniang Panlalawigan pursuant to Article III Section 468(a)(1)(i) of RA 7160, the August Body finds the enactment of the Municipal Ordinance No. 13, series of 2022, is within the prescribed powers of the Sangguniang Bayan.
