**A RESOLUTION ENDORSING TO THE HONORABLE GOVERNOR CORAZON N. MALANYAON, THE HEREIN LETTER OF THE FORMER PROVINCIAL GOVERNOR, HONORABLE NELSON L. DAYANGHIRANG, DATED JUNE 9, 2022, RELATIVE TO THE REQUEST FOR A PASSAGE OF A RESOLUTION FROM THE 16TH SANGGUNIANG PANLALAWIGAN, AN AUTHORITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA), FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, WITH THE MUNICIPAL LOCAL GOVERNMENT UNIT OF BOSTON, FOR WHATEVER ACTION DEEMED APPROPRIATE THEREOF.**

**WHEREAS**, the former Provincial Governor Nelson L. Dayanghirang, in his letter, dated June 9, 2022, requested the 16th Sangguniang Panlalawigan for the passage of a resolution authorizing him, for and in behalf of the Provincial Government of Davao



Oriental, to enter into a Memorandum of Agreement with the Municipal Local Government Unit of Boston, represented by its Municipal Mayor, Honorable Rowell F. Rosit, for the effective and efficient implementation of financial assistance to drug dependents, including the systematic transferring and reimbursement process for LGU-managed rehabilitation centers;

**WHEREAS**, the said request was not acted upon by the 16th Sanggunian due to lack of material time;

**WHEREAS**, the same was endorsed to the 17th Sangguniang Panlalawigan for appropriate action, through the Committee on Dangerous or Illegal Drugs;

**WHEREAS**, this August Body believed that under the new administration of the new Provincial Governor, the request for authority to be granted to Former Provincial Governor Nelson L. Dayanghirang, now 1<sup>st</sup> District Representative of the province, was no longer applicable, hence, a need to endorse the same to the present Local Chief Executive for whatever action deemed appropriate thereof;
