

A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR CORAZON N. MALANYAON, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES - ENVIRONMENTAL MANAGEMENT BUREAU (EMB), REPRESENTED BY ITS REGIONAL DIRECTOR, MARIO N. BULACAN, PME, MPA, RELATIVE TO THE ASSESSMENT, SUPPLY, DELIVERY AND INSTALLATION OF BRAND NEW PRELIMINARY DISINFECTION AND STORAGE FACILITIES FOR COLLECTED COVID-19 RELATED WASTE.

WHEREAS, pursuant to Chapter 3, Section 465(b)(1)(vi) of the Local Government Code of 1991 stated among others, "the provincial governor, as the chief executive of the provincial government, shall represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan or pursuant to law or ordinance";

WHEREAS, as the COVID-19 pandemic continues, the waste generation from quarantine facilities and vaccination centers is significantly increasing;

WHEREAS, the challenges of improper collection, preliminary disinfection and storage of Personal Protective Equipment, syringes, vials and other COVID-19 related healthcare wastes will be addressed by the Preliminary Disinfection and Storage Facilities Project proposed by The Department of Environment and Natural Resources, through the Environmental Management Bureau facilities which was approved during the Calendar Year 2022 Budget Hearing. Furthermore, the aforementioned project will improve the collection of COVID-19 related healthcare wastes from quarantine facilities, testing facilities, and vaccination sites located in remote areas including small generators that are not serviced by a Treatment, Storage and Disposal Facilities;

WHEREAS, the Provincial Government of Davao Oriental has been selected as one of the recipients of Brand New Preliminary Disinfection and Storage Facility for Collected Covid-19 Related Waste in a manner consistent with the Technical Specifications and provisions stated in the Memorandum of Agreement;

WHEREFORE, on motion of SP Member Eleuterio C. Manaytay, duly and jointly seconded by SP Members Andy A. Monday, Marietta D. Palmera, Harold A. Montes, Daud V. Linsag, and Stephen Paul L. Uy, it was
