WHEREAS, Chapter 2, Section 17(a) of Republic Act 7160, states that: *“Local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. xxx and shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities xxx”*;

WHEREAS, considering that the Committee has been given only 30 days to act on any referrals after it has been referred to the appropriate committee, as quoted in Section 6, Rule XII, of the Internal Rules of Procedure of the 17th SP, thus virtual meeting platform through video conferencing is deemed necessary, hence, it provides an easy way to expedite the legislative process, in the deliberation of various referrals, and urgent matters, in the exigency of service for an efficient, effective and economical governance of this province;

WHEREAS, taking into consideration, that health crisis caused by COVID-19 virus continue to threaten the lives of individuals, that impede instantaneous legislative action in the Sanggunian due to some restrictions, thus the committee cannot convene physically, but must act on legislations that need immediate action in times of the aforesaid situations;

WHEREAS, by establishing a ‘virtual’ presence through “video conferencing”, speedy disposition of urgent matters during emergencies and calamities and those matters which are ministerial in nature that need legislative action can be promptly acted;

WHEREFORE, on motion of SP Member Nelson R. Dayanghirang, Jr., duly and jointly seconded by SP Members Harold A. Montes, Daud V. Linsag, Stephen Paul L. Uy, Eleuterio C. Manaytay, Manuel M. Lepardo, Jr., and Marietta D. Palmera, it was;
