WHEREAS, Section 16 of the Local Government Code of 1991 states that: *“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare xxx”;*

WHEREAS, Municipal Ordinance No. 2022-05, otherwise known as *“Revised and Updated Code of General Ordinance of Lupon, Davao Oriental”*, was enacted by the 19th Sangguniang Bayan of Lupon on its 142nd Regular Session held last June 6,


