Don Mariano Marcos – Macangao Road (Don Mariano Marcos - Malig - Calasagan - San Isidro - New Visayas - Tagboa - Macangao Road)	31.055 Km
Mati - Tarragona Road (Mati - Tarragona Bypass Road)	3.471 Km




