

A RESOLUTION INTERPOSING NO OBJECTION TO THE PROPOSED CONVERSION OF MATI AIRPORT ROAD, FATIMA PAROLA ROAD, AND BOBON TO LAWIGAN ROAD INTO NATIONAL ROADS.

WHEREAS, the DPWH - 2nd Engineering District, through Engr. Jane D. Cainghog, District Engineer, has requested then Provincial Governor Nelson L. Dayanghirang, for the conversion of the following local roads to national roads, to wit:

a. Mati Airport Road (Jct. Pres. Diosdado P. Macapagal to Mati Airport Road)

Kuplaza Cymalanyson

b.	Fatima Parola Road (Lavigan to Fatima Parola Road)	4,500 m
C.	Bobon to Lawigan Road	13.115 m

WHEREAS, former 2nd District Representative of Davao Oriental, Congressman Joel Mayo Z. Almario, in his letter dated June 8, 2022, has also requested then Provincial Governor Nelson L. Dayanghirang, through the 16th Sangguniang Panlalawigan, for a Provincial Resolution endorsing the proposed conversion of the said Local Roads into National Roads;

WHEREAS, the Provincial Development Council Executive Committee through PDC-EXCOM Resolution No. 15, series of 2022, supports the proposed conversion of the aforementioned local roads into national roads;

WHEREAS, the August Body interposes no objection on the proposed conversion of the identified local roads into national roads, for it would be beneficial to the Provincial Government of Davao Oriental, as it will improve and maintain the road conditions and the longevity of the road assets to ensure an efficient road system, thus improving transport of commodities and public accessibility;

WHEREFORE, on motion of SP Member Manuel M. Lepardo, Jr., duly and jointly seconded by SP Members Harold A. Montes and Daud V. Linsag, it was;

RESOLVED, as it is hereby resolved, INTERPOSING NO OBJECTION TO THE PROPOSED CONVERSION OF MATI AIRPORT ROAD, FATIMA PAROLA ROAD, AND BOBON TO LAWIGAN ROAD INTO NATIONAL ROADS;
