A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE GOVERNOR CORAZON N. MALANYAON, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DAVAO ORIENTAL STATE UNIVERSITY (DORSU), REPRESENTED BY ITS PRESIDENT, DR. ROY G. PONCE. RELATIVE TO THE SECONDMENT OF DR. EDITO B. SUMILE, AS THE DESIGNATED HEAD OF THE PROVINCIAL AGRICULTURE OFFICE.

WHEREAS, the Local Chief Executive has requested the Sangguniang Panlalawigan for the passage of a resolution authorizing her to enter into an agreement with the Davao Oriental State University relative to the secondment of Dr. Edito B. Sumile:

WHEREAS, Section 6 (c), Rule III of the Civil Service Memorandum Circular No. 15, Series of 1999 defined Secondment as a movement of an employee from one department or agency to another which is temporary in nature and which may or may not require the issuance of an appointment which may either involve increase in compensation and benefits. Paragraph (iv) 1, provides among others that: approval of the Secondment shall be done through a Memorandum of Agreement between the Mother Agency and the Receiving Agency and concurred by the employee;

WHEREAS, the Provincial Government of Davao Oriental recognizes the significant involvement of the academe in developing science-based agriculture, and President Emeritus Dr. Edito B. Sumile, a College Professor of the Davao Oriental State University, possesses the necessary technical expertise, experience, and management skills to directly oversee the Provincial Agriculture Office;

WHEREAS, the period of his secondment is allowed for a maximum of three (3) years, with the salary and other compensations provided by the Provincial Government in accordance with his salary grade, chargeable against the General Fund of the province, subject to government accounting and auditing rules and regulations;

WHEREAS, in addition to the specific duties and functions stipulated in the draft Memorandum of Agreement (MOA), it is recommended that the Secondee shall also perform functions of the Provincial Agriculturist pursuant to Article XII Section 482 (b) and (c) of Republic Act No. 7160, and that the provisions under Section 482 (c) of the same Act be added in the final Memorandum of Agreement (MOA) specifically under the Delineated Functions and Responsibilities of the Secondee.

WHEREFORE, on motion of SP Member Marietta D. Palmera, duly and jointly seconded by SP Members Daud V. Linsag, Stephen Paul L. Uy, Harold A. Montes Eleuterio C. Manaytay, and Andy A. Monday, it was
