**A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 01, SERIES OF 2022, OF THE MUNICIPALITY OF GOVERNOR GENEROSO, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.**

**WHEREAS**, Appropriation Ordinance No. 01, series of 2022, of the Municipality of Governor Generoso, Davao Oriental, authorizing its CY 2022 General Fund Supplemental Budget No. 01, involving an appropriation of **Ten Million Seven Hundred Seven Thousand Three Hundred Eighty Seven Pesos & 43/100 (P 10,707,387.43)**, was submitted to this Sanggunian for review on April 20, 2022, pursuant to the provisions of Republic Act No. 7160;

**WHEREAS**, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 01, series of 2022, of the Municipality of Governor Generoso, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the condition that the LGU shall adapt measure by not filling-up vacant funded positions except for mandatory one, and no creation of positions, in order to reduce the excess of 6% in the amount equivalent to that which is within the exact 45% limitation, pursuant to DBM LBC No. 98 dated October 14, 2011 and Section 325(a) of RA 7160.

**RESOLVED FURTHER**, to inform the Municipality of Governor Generoso, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

**MOREOVER**, the Local Government Unit is reminded of the relevant provision under the Budget Operation Manual for Local Government Units issued under Local Budget Circular No. 112, dated June 10, 2016, in relation to Sections 56(a) and 327 of RA 7160 and Article 110 of its Implementing Rules and Regulations (IRR) which requires that, "*Within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said ordinance to the Department of Budget and Management or Sangguniang Panlalawigan for review.*"

**RESOLVED FINALLY**, to send a copy of this Resolution to the Sangguniang Bayan of Governor Generoso, Davao Oriental, through the Municipal Mayor.




